"Wild Parents" will follow the animal crew as they walk the preserve and watch as the wild ones get a femur bone, thrown over the fence (for the very low cost of \$10 each). You will delight in seeing your animal enjoy this delicious treat! You may bring a snack and after the animals get their bones, go to Lake Shambala to eat and enjoy the company of the other adoptive parents.



The first step in joining the distinctive group of Adoptive Parents is to choose your "Wild One". After your third monthly payment you will receive an 8"x10" photo of your "Wild One", and a Certificate of Adoption. When you visit on Parent's Day a member of the Shambala animal crew will be happy to tell you about the characteristics of the species and the individual personality traits of your special animal. ALL VISITORS MUST BE AT LEAST 18 YEARS OLD. PETS ARE NOT ALLOWED ON THE PROPERTY.
